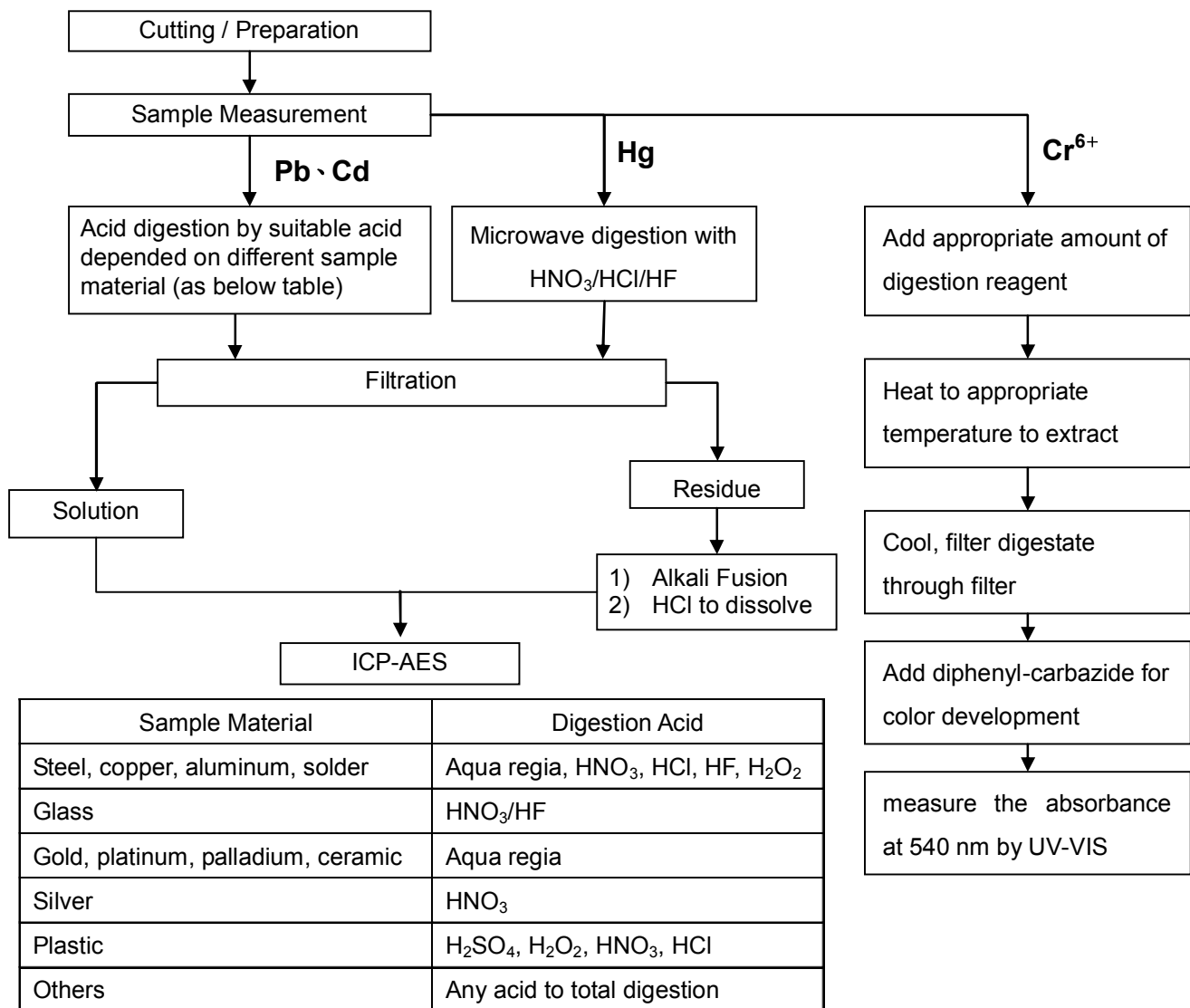

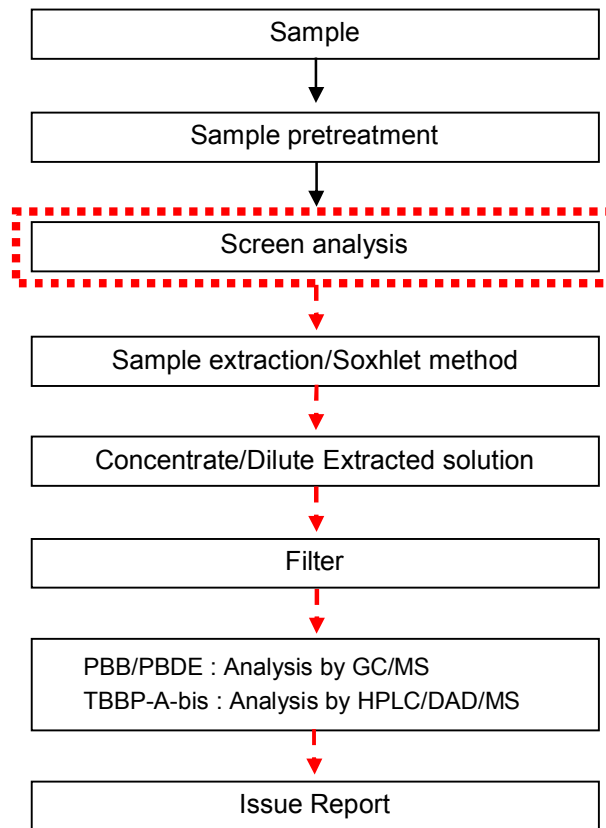


Analytical flow chart

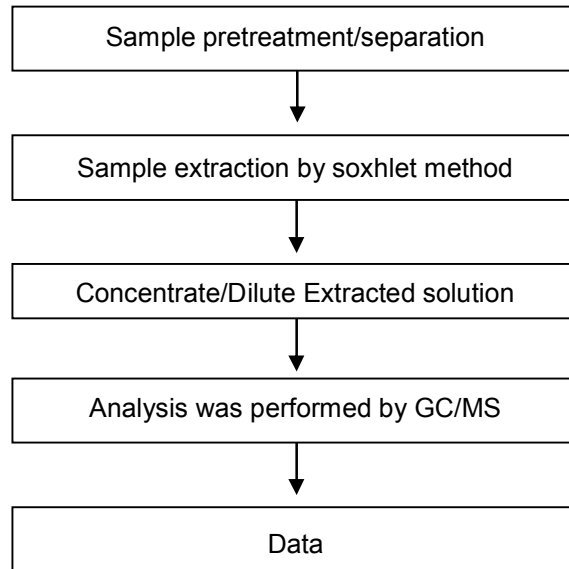
